**Consolidated Post Reports:** Chairman Geiger reported that a total of about 260 CPR's were turned in by the June 5, 2009 deadline. These reports were reviewed on June 6, 2009 at Department Headquarters for awards and recognition. Department will continue to accept these reports from the Posts that did not send them in if they can do so immediately after Convention so that they can be counted by National, the deadline is June 30, 2009. The ones turned in after Convention will not be eligible for the Department awards. District and Post awards from the CPR's were announced.

Chairman Geiger reported that 7 families in Michigan were awarded a total of \$8,091.78 for Temporary Financial Assistance. 9 applications were denied. Chairman Geiger stated that the dollar amount is over \$2,000 less than last year and with the economy in Michigan, we need to start at the Post level to find those in need of TFA. Chairman Gieger also related to an article by Department Adjutant **Lafferty** regarding TFA applications falling short for 2008 MI Vet families, printed in the March Michigan Legionnaire.

OMK was discussed and who participated this past year.

SAL Danny Poole gave a report as to what they have done.

Walt McVeigh reported on Tabs for Tots and what had been done in the 5<sup>th</sup> District.

**NEW BUSINESS:**


There were no resolutions to be acted on.
