Article IV, Section 4(j) reads as follows: "In addition to the newly elected Post Commander each Post shall select one delegate for each 50 paid-up members, or major fraction thereof, to represent such Post at the annual Convention. Each Post shall select an alternate for each delegate chosen. The delegates and alternates shall be chosen by each Post from among its own members in good standing."

The names of all delegates and alternates shall be certified to the Department Adjutant at least ten (10) days before the opening of the annual Convention. Department Headquarters will certify all Delegate Certification forms on June 08, 2010.

These Certification Forms will then be prepared for the Convention Credentials Chairman and committee at State Convention. The Convention Credentials Committee will meet at the Hyatt Regency on Friday, June 18, 2010 at 8:30 a.m.

The Convention Credentials Committee consists of a chairman, appointed by the Department Commander, plus a representative from each of our sixteen (16) Districts, which are appointed by their respective Districts.

The Convention Credentials Committee Chairman will report the delegate strength of the Convention immediately following the opening of the Dearborn, Convention at 2:00 p.m. Friday June 18, 2010
