INSCRIPTION: "Sons of The American Legion Award in memory of Maurice L. Michael"

PRESENTED BY: Mrs. Marie Michael, widow of Maurice L. Michael, in 1957 in memory of this man

who took an active part in the S.A.L. program in Detroit and served the

Department on the Detachment S.A.L. Committee from 1948 until his death in

1953.

GENERAL: Light oak wood consisting of a base of two layers with two sunray eagles on

either side and wood column in center topped by a sunray figure and on the front

of column the inscription.

HOW AWARDED:

To be awarded annually to the Squadron which is judged on the basis of reports submitted to the Department Headquarters as having the best S.A.L. program in the State.

CONDITIONS:

- 1. Title of this trophy is to remain in The American Legion, Department of Michigan.
- 2. By mandate of the 1953 Department Convention, the original trophy is to remain at Department Headquarters on exhibit and in the stead of physical delivery of the original trophy to the winner, a small plaque, properly engraved, shall be supplied and presented by the Department at each Department Convention, with said plaque being retained by the adjudged winner. Suitable engraving shall be made upon the original trophy for record and posterity.
- 3. Said trophy is to be awarded annually to the squadron with the best S.A.L. program in the State of Michigan for that particular year.
- 4. The award shall be based on the information supplied by the squadron on form provided by the Detachment S.A.L. Committee, and filed with Department Headquarters.
- 5. Winner shall be determined by the Detachment S.A.L. Committee.
